Amendment to the Articles of Incorporation:

Article 2:

- A. To provide, coordinate, or assist educational endeavors relating to Oracle and other technologies.**
- B. To collect, post, and disseminate information about Oracle and other related technologies.**
- C. To provide a channel of communication between our members and Oracle Corporation or other related technologies.**
- D. To foster and facilitate communications between members and other user group organizations.**
- E. To support educational opportunities to individuals in the Information Technology field through scholarships, grants, and directed funding.**

Article 8:

The assets of the Corporation in the process of dissolution shall be applied and distributed as follows:

- A. All liabilities and obligations of the Corporation shall be paid and discharged, or adequate provisions shall be made therefore.**
- B. Assets held by the corporation on condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirement.**
- C. All other assets, if any, shall be donated to a charitable educational organization or organizations that are exempt under section 501(C)(3) upon dissolution.**
