Amendment to the Articles of Incorporation:

Article 2:

- A. To provide, coordinate, or assist educational endeavors relating to Oracle and other technologies.
- B. To collect, post, and disseminate information about Oracle and other related technologies.
- C. To provide a channel of communication between our members and Oracle Corporation or other related technologies.
- D. To foster and facilitate communications between members and other user group organizations.
